And of course, the entertainment is distinctly Canadian, with several Maritime musical styles and themed activities on the social program. Come and experience traditional Maritime hospitality at its best!



CCSBE Lifetime Achievement Award Winner, Gar Pynn, Passes Away

Gar Pynn, former director of Memorial University's School of Business Administration and Commerce, passed away on July 18, 2007 after a long and courageous battle with cancer.

Professor Pynn was a graduate of Memorial's Bachelor of Commerce program and soon after completing his MBA at the University of Western Ontario he returned to Memorial in the position of assistant professor of business. He was instrumental in the establishment of the business co-op program, the first of its kind in Canada. He served as director of Memorial's School of Business Administration from 1974 to 1979. While in the position, he established the first centre for small business support at a Canadian university, the P.J. Gardiner Institute for Small Business Studies.

The P.J. Gardiner Institute stands as a legacy of Gar's contribution to the field of entrepreneurship education and development. In 2004, the Canadian Council for Small Business and Entrepreneurship recognized his accomplishments with the Lifetime Achievement Award for his leadership, advocacy and contribution to the field of entrepreneurship education and small business development. Professor Pynn remained actively involved with the P.J. Gardiner Institute until his death.

Professor Pynn retired in 1996 at the rank of full professor after 27 years of service to the university; however he never really retired from his love of teaching and his passion for entrepreneurship and small business. He continued to teach with Memorial's Faculty of Business as a part-time instructor until three weeks before his death and in 2006 he spent a semester at the Harlow campus, running Memorial's business program in England.

Gar brought his passion for small business and entrepreneurship to countless students and he also shared his passion and expertise with the entire province. From 1972 to 1980, he served as the director of the Newfoundland Institute for Management Advancement and Training. In 1979, he was the founding director of the International Council for Small Business (ICSB) Canada. He served as vice-president of ICSB from 1979 to 1988. In 1988, Professor Pynn was a member and fellow of the Founding Council of the National Entrepreneurship Development Institute. Between 1988 and 1992 he was involved in a community development project in Thailand aimed at encouraging women in rural Thailand to start small businesses.

Professor Pynn was active in the research and academic community. He served as a member of the Social Sciences and Humanities Research Council consultative group on Research in Canadian Business Schools to ensure that business schools in Canada received a reasonable share of SSHRC funding. He was chairman of the Association of Universities and Colleges in Canada and a member of the graduate scholarship committee.

Outside of academic life, Gar served as the chairman on a provincial committee to study the remuneration levels of members of the House of Assembly and he was also commissioner for the Royal Commission on Hospital and Nursing Home Costs.

Professor Pynn's contribution to Memorial's Faculty of Business was recognized by an anonymous donation in 1997 that created the Gar Pynn Scholarship in Business, in recognition of his contribution to the Faculty of Business Administration over his 27 years of service.

Gar will be dearly missed by his colleagues, friends and students. He has been a role model and mentor to many, and his passion has helped shape small business and entrepreneurship education provincially, nationally and internationally.

U of R professor sends farming equipment "and hope" to African village

Within the next few days, a forty-foot shipping container packed with farming equipment and other tools will begin a long journey traveling from the Queen City to the Democratic Republic of the Congo. Going by train to Montreal, and then by ship to Europe, the Middle East and Tanzania before making the final rail trip to the Congo, the container will bring a new way of life and a renewed sense of hope to a small Congolese village.

The container of equipment is the product of two years of work by Jean-Marie Nkongolo-Bakenda, a U of R professor of International Business and Strategy. He is president of the Association for the Development of the Rural Communities in Congo (ADERC). Destined for a village in the province of Eastern Kasai, the container holds a wide variety of equipment including a tractor, three cultivators, a tiller, a three tonne grain truck, a brick press for regular bricks made with clay, a brick press for interlocking clay bricks, a roller mill, two air compressors, one generator, and woodworking equipment.

The project grew out of Nkongolo-Bakenda's 2006 return to the small Congolese city of Gandajika * a place he had last visited 40 years before.

"When I visited Gandajika and its neighbouring villages, I was shocked at how badly living conditions had deteriorated over the intervening 40 years," Nkongolo-Bakenda says. "There were no seats for children in many of the schools, and in many cases the schools could not operate full-time because both the teachers and the children had to work in the fields several days a week. That is no way for children to learn, or for a community to improve its productivity and way of life."

In discussion with local officials, Nkongolo-Bakenda learned that working and learning conditions in local villages could be improved if agricultural practices could be made more efficient. This would allow children and teachers to spend more time in school and less in the field, at the same time allowing farmers to increase their productivity and generate more income. At that time, he resolved to find a way to send much-needed equipment to one village in an effort to start a long-term agricultural and business development program that could spread from village to village. In many cases, he and his fellow ADERC members purchased and refurbished the equipment at their own monetary expense.

"The idea is to ship the equipment to a village called Ba Mpiana," Nkongolo-Bakenda says. "Using the equipment, the villagers will be able to improve their efficiency and way of life through a sort of agricultural co-op, eventually earning enough money to rebuild schools and purchase additional equipment that can be used in neighbouring villages. The long-term goal is to break the cycle of dependency in the area through business development."

After its long journey, the container of equipment is expected to arrive in Ba Mpiana sometime in May or June of this year.

The Telfer Women and Enterprise Working Papers Series

As Canadians celebrate International Women's Day on March 8th, the Telfer School of Management at the University of Ottawa, as a result of a research partnership with Industry Canada Small Business Policy Branch, are pleased to release new research about women entrepreneurs in export markets.

Gender and Export Propensity examines the influence of gender in international trade. This is an important study because international trade is critical to the Canadian economy, SMEs comprise the majority of the firms that sell goods and services abroad and women are increasingly engaged in international entrepreneurial activities.

The study found that women-owned firms are underrepresented among SME exporters. Approximately 17 percent of Canadian small- and medium-sized enterprises are majority women-owned (with ownership between 51 and 100 percent). Among Canadian SME exporters, only 12 percent of firms are majority women-owned. The study also found that gender differences in operational attributes of the firm explain most, but not all gender differences in export

propensity. The study implies that women business owners face unique challenges to international trade. Furthermore:

- The impact of gender on export propensity appears to differ by sector.
- Firms owned by women immigrants appear to be more likely to export, all other factors held equal;
- Majority women-owned firms were less likely to seek growth, reported less management and financial experience and operated smaller, less profitable firms and firms that were concentrated in service sectors; and
- On average, exporters are larger firms, located in urban settings, operating in manufacturing, wholesale/retail, professional services and technology-based sectors and reporting higher than average investments in R&D. Owners were more likely to report that their first language was not French, were disproportionately immigrants (Canadian resident of less than 5 years) and were significantly more likely to intend to grow the firm.

The findings suggest that growth-oriented, women business owners might consider exporting as a means to enterprise growth, regardless of firm size, age or sector.
